Dr. Biehl joined St. John's University in Spring 2022 as an Assistant Professor in the [Department of Philosophy](#), after having earned a B.A. from St. John's and a Ph.D. from the Graduate School and University Center of the City University of New York.

With a particular concentration on business ethics and the philosophy of the city, his work focuses on how traditional philosophical concerns about truth, justice, and meaning are manifested (and often obscured) in contemporary society. He is the founder and executive director of the [Gotham Philosophical Society, Inc.](#), a 501(c)(3) that uses the critical rigor and analytical imagination of philosophical thought to transform the civil, political, and educational institutions of New York City.



**Nidal Daou, Ph.D.**

Dr. Daou comes to St. John's University as an Associate Professor in the [Department of Psychology](#). She earned her Ph.D. in Psychology from the Learning Processes and Behavior Analysis subprogram at The Graduate Center, City University of New York. Her research interests include social interaction and independent engagement among children and adolescents on the autism spectrum. Inspired by the neurodiversity movement, she recently found a great interest in encouraging a participatory research approach in Applied Behavior Analysis.



**Emine Karaman, Ph.D.**

Dr. Karaman comes to St. John's University as an Assistant Professor in the [Department of Physics](#). She earned a B.S. degree in Physics, an M.S. degree in Biomedical Engineering, and a Ph.D. in Materials Science and Engineering from

the New Jersey Institute of Technology. Her research interests involve the structural, electrical, and electrochemical properties of electrode materials and their application in energy storage devices, as well as computational modeling using density functional theory calculations to gain an understanding of the mechanisms underlying the observed properties of these experimental studies. She has gained an awareness of the intellectual needs of students spanning a range of backgrounds, diversity, and academic levels due to her experience teaching at various colleges including Nassau Community College, SUNY Maritime, Hofstra University, and Yeshiva University.



**Xue Mei, Ph.D.**

Dr. Mei comes to St. John's University as an Assistant Professor in the [Department of Biological Sciences](#). She earned her doctoral degree in Cell and Developmental Biology from the University of Iowa, where she worked on cellular signaling pathways during embryonic

development and disease.

After her Ph.D., she worked as a postdoctoral fellow at [Cincinnati Children's Hospital Medical Center](#), where she studied light-sensing molecules in the development and function of the eye. She then moved to Rutgers University, where she worked in Andrew Singson, Ph.D.'s lab to study reproduction in the experimental model animal, roundworm. Her current work explores the molecular mechanisms of fertilization, using genetic and biochemical approaches.

Having earned a Ph.D. in Philosophy from Princeton University, Dr. Perring joined St. John's University in Spring 2022 as an Assistant Professor in the [Department of Philosophy](#). His areas of research are in the philosophy of psychiatry and psychology, philosophy of medicine, and medical ethics. He

## Vaibhav Anand, Ph.D.

Dr. Anand joins St. John's University's [Maurice R. Greenberg School of Risk Management, Insurance and Actuarial Science](#) as an Assistant Professor. He completed his Ph.D. in Risk and Insurance at the University of Wisconsin-Madison. His research examines how people and firms make decisions under risk and uncertainty.

Prior to joining the doctoral program at UW-Madison, Dr. Anand worked for nine years in financial services, specializing in credit risk analytics. His teaching interests are closely aligned with his research and professional experience. He looks forward to teaching courses in risk management and insurance, insurance economics, and risk analytics.

In addition to the Ph.D., he holds a Bachelor of Technology in Engineering Physics from IIT-Bombay, India; a Post Graduate Diploma in Management from IIM-Lucknow, India; and Financial Risk Manager certification from the Global Association of Risk Professionals.



**Rachel Marie Brooks Atkins, Ph.D.**

Dr. Atkins comes to St. John’s University as an Assistant Professor in the [Department of Economics and Finance](#). She is a 2020 graduate of The New School, having earned a Ph.D. in Public and Urban Policy. Her research examines racial economic inequality among entrepreneurs and workers, especially those in high technology sectors. In her

dissertation, Dr. Atkins investigated whether and how disparities in entrepreneurship entry or exit among Blacks and Whites in the US varied over the business cycle. She further examined the extent to which cyclical changes in labor and housing markets explained variation in the disparities.

She has published work examining racial disparities in entrepreneurship during the Great Recession, and racial differences in loans received by small businesses from the Paycheck Protection Program in response to the COVID-19 pandemic. Dr. Atkins is completing the final year of the Provost’s Postdoctoral Faculty Fellowship at New York University.



**Shima Azizi, Ph.D.**

Dr. Azizi joins St. John’s University as an Assistant Professor in the [Department of Business Analytics and Information Systems](#), teaching courses in prescriptive and predictive analytics and operations management. Her research focuses on the use of advanced analytics, specifically operations research

and data science, to solve practical problems in humanitarian operations, health care, and sustainability.

Prior to joining St. John’s, she investigated alleviating challenges within refugee camp systems, the US foster care system, as well as in US community paramedicine programs. Dr. Azizi earned her Ph.D. in Operations Management from Worcester Polytechnic Institute, her M.Sc. in Industrial Engineering from the University of Kurdistan, and her B.Sc. in Industrial Engineering from the University of Tabriz.



**Natalie Dixon**

Professor Dixon joins St. John’s University as a Visiting Assistant Professor in the [Department of Accountancy](#). She earned a Master of Accountancy degree and is a Candidate for the D.B.A. in Accounting from The University of Scranton.

Her dissertation research involves academic dishonesty. More specifically, her work focuses on finding effective solutions to aid administrators and the accounting profession to enforce ethical standards, with the objective to reduce fraud in accounting students—who are the next generation of professionals. Other areas of interest include corporate social responsibility and business ethics.



**Michael Herley, D.B.A. '96MBA**

Dr. Herley comes to St. John's University as a Visiting Assistant Professor in the [Department of Business Analytics and Information Systems](#). He earned a D.B.A. in Finance from Sacred Heart University's Jack Welch College of Business and Technology, an M.B.A. in Corporate Finance from

**Ansel Felix Schiavone, Ph.D.**

Dr. Schiavone joins St. John's University as an Assistant Professor in the [Department of Economics and Finance](#). Having earned a Ph.D. in Economics from the University of Utah, his research focuses on inequality, structural change, and stagnation. His most recent work includes

an article, "Essentially Unemployed," published in the [Review of Social Economy](#), in which he analyzed the impacts of COVID-19 on income inequality. He has also published in journals such as [Regional Studies](#) and [Metroeconomica](#), and is coauthor of a chapter in a forthcoming book, *The Great Polarization: Economics, Institutions, and Policies in the Age of Inequality*. He teaches a wide range of subjects, from econometrics to economic history.

Dr. Bu comes to the faculty of St. John's University as an Assistant Professor in the [Department of Pharmaceutical Sciences](#). She earned her Ph.D. in Toxicology from the Department of Pharmacology, Toxicology, and Therapeutics at the University of Kansas Medical Center and completed her

postdoctoral training there in the Department of Pathology and Laboratory Medicine.

Prior to joining St. John's University, Dr. Bu spent three years as an Assistant Professor in the College of Pharmacy at Rosalind Franklin University of Medicine and Science. Her research interests include harnessing herbal medicine for Leydig cell protection, investigating transporters as biomarkers for precision and personalized cancer therapy, and safety assessment of biopharmaceuticals.



## Hyunah Cho, Ph.D.

Dr. Cho comes to the faculty of St. John's University as an Assistant Professor in the [Department of Pharmaceutical Sciences](#). She earned her B.Pharm. and M.S. in Pharmaceutical Sciences from Sookmyung Women's University, Seoul, South Korea, and earned her Ph.D. in Pharmaceutical

Sciences from the University of Wisconsin-Madison. She also earned her M.A. in Higher Education Administration from Fairleigh Dickinson University.

Prior to joining St. John's University, she worked as an Assistant Professor at the University of Health Sciences and Pharmacy in St. Louis, MO, for 3.5 years and as an Associate Professor at Fairleigh Dickinson University for 4.5 years. Dr. Cho's current research interests include nano-based drug delivery systems, 3D-printing of dosage forms, optical image-guided surgery, combination chemotherapy, and cosmeceuticals.

and a Master of Arts in Education with a specialization in Higher Education from the University of Arizona. Prof. Choi-Gomes has been a licensed and certified clinical laboratory scientist for 25 years.

For the past eight years, Prof. Choi-Gomes was a Clinical Chemistry Laboratory Supervisor at [Flushing Hospital Medical Center](#), and an adjunct instructor of Clinical Chemistry in the Clinical Laboratory Science program at St. John's University for the past three years. Her research interests are in improvements of specificities and sensitivities of viral antibody detection.



**John Dorangricchia, D.P.T.**

Dr. Dorangricchia joined St. John's University in Spring 2022 as an Assistant Professor in the [Doctor of Physical Therapy](#) program within the [Department of Clinical Health Professions](#). He earned his B.S. in Health Sciences with a concentration in Medical Informatics at Stony Brook University and his

Doctor of Physical Therapy at Long Island University.

Prior to joining St. John's University, he practiced at [Rusk Rehabilitation](#) for nine years, where he received advanced training in vestibular and neurological rehabilitation. Dr. Dorangricchia has appeared on Sirius XM's *Doctor Radio—The Otolaryngology Show* as a guest expert in vestibular rehabilitation, and has an episode on the *Rusk Insight on Rehabilitation Medicine* podcast. He has served as a clinical instructor in both inpatient and outpatient settings, where he taught entry-level students the applications of neurological rehabilitative principles.

Dr. Dorangricchia's research and teaching interests include the assessment and treatment of vestibular disorders, cervicogenic dizziness, concussions, and other neurologic disorders.



**Sei Higuchi, Ph.D.**

Dr. Higuchi joins St. John's University as an Assistant Professor in the [Department of Pharmaceutical Sciences](#). He earned his B.A. and M.S. in Pharmaceutical Sciences from the pharmacy school at Josai International University in Japan. He earned his Ph.D. in Pharmaceutical Sciences from

Fukuoka University (Japan), and is a licensed Japanese pharmacist.

Dr. Higuchi has been working on lipid metabolism research for more than 10 years and his research goal is to propose a novel approach to treat obesity and metabolic-related diseases. As a graduate student, he trained in behavioral pharmacology and neuroscience. He spent four years as a postdoctoral research scientist at Kyoto University (Japan), after which he spent seven years at Columbia University to train in intestinal lipid metabolism with a focus on the role of bile acids in intestinal lipid metabolism. His work revealed that bile acids act as regulators of intestinal lipid sensing and food intake regulation.

As he starts an independent laboratory, Dr. Higuchi will focus on intestinal lipid sensing in obesity and obesity-related diseases in three subject areas: satiety and satiation regulation system; fatty food appetite; and obesity-related inflammation and neurodegenerative disease such as depression.



**Francine Laterza, Ed.D., R.N., PNP, CNE**

Dr. Laterza joins the faculty of St. John's University as an Associate Professor/Industry Professional in the [Department of Clinical Health Professions](#), and Clinical Coordinator of St. John's [B.S. degree program in Nursing](#). She has been in the nursing profession for more than 30 years, with 18 years

of clinical practice as a registered nurse and pediatric nurse practitioner and 14 years in nursing education serving as faculty, program coordinator, and program director.

Dr. Laterza earned her Ed.D. in Nursing Education from Western Connecticut State University in Danbury, CT; her M.S. degree in Nursing/Pediatric Nurse Practitioner from Hunter College in New York, NY; and a B.S. degree in Nursing from St. Joseph's College in Brooklyn, NY. In addition, Dr. Laterza is a [National League for Nursing](#) Certified Nurse Educator.

Dr. Laterza is committed to contributing her teaching, service, and scholarship to the College and to educating the next generation of registered professional nurses. 


**Jessica Varghese, Ph.D.**

**Shanzhi Wang, Ph.D.**



## Meghan Dunn, Ph.D.

Dr. Dunn joined St. John's University three years ago as an Assistant Professor in the [Department of Rhetoric, Communication, and Theatre](#), and is now a member of the tenure-track faculty in the [Division of Mass Communication](#) as an Assistant Professor of Public Relations. She earned her Ph.D.

in Communication Studies/Rhetoric from the University of Colorado at Boulder and an M.A. in Communication Studies/Rhetoric from the University of Texas at Austin.

Her research investigates how information, knowledge, or truth(s) are conducted through emergent technologies or 'novel' media, especially by marginalized communities in times of disaster, crisis, and political upheaval. Prof. McClendon joins St. John’s University as an Assistant Professor/Industry Professional of Fashion Studies in the [Division of Administration and Economics](#). She earned her M.A. in History of Dress from The Courtauld Institute of Art in London and an M.A. Hons. in Art History from The

University of St. Andrews in Scotland. Prior to coming to St. John’s University, Prof. McClendon worked as a curator at [The Museum at The Fashion Institute of Technology](#) (FIT) for nine years and taught in the Fashion Studies programs at Parsons School of Design and at FIT.

Her research focuses on the power dynamics inherent in the international fashion industry with a particular interest in body politics, labor, technology, and standardized sizing. **Miriam A. Cherry, J.D.**

Prof. Cherry joins St. John's University's [School of Law](#) as Professor and faculty Codirector of the [Center for Labor and Employment Law](#). She holds a B.A. from Dartmouth College and a J.D. from Harvard Law School, and clerked for the Massachusetts Supreme Judicial Court and the

US Court of Appeals for the Eighth Circuit after graduation from law school. Prior to joining St. John's, Prof. Cherry taught at Saint Louis University Law School and the University of the Pacific.

Prof. Cherry's research focuses on the future of work, technology, and globalization. She is the author of more than 40 published law review articles and books, and her latest book is under contract with [Cambridge University Press](#). She is an elected member of the [American Law Institute](#) and the former Chair of The Association of [American Law Schools Section on Contracts](#).



**Martin J. LaFalce, J.D.**

Prof. LaFalce joined the St. John's [School of Law](#) faculty in Spring 2022 as an Assistant Professor of Clinical Legal Education and Director of the Defense and Advocacy Clinic.

Prof. LaFalce spent 14 years as a public defender at [The Legal Aid Society](#). He began his career representing clients at Rikers Island charged with violating the conditions of their parole. In that role, he pursued impact litigation that led the Appellate Division, First Department, to strike down the [New York State Board of Parole's](#) draconian board review procedure, a procedure that allowed parole commissioners to unilaterally imprison New Yorkers without affording them a hearing.

Prof. LaFalce also worked as trial attorney in Manhattan for 10 years, representing New Yorkers charged with crimes ranging from low-level marijuana possession to murder. During that time, Prof. LaFalce teamed with Legal Aid colleagues, community activists, and state legislators to repeal New York State's discriminatory gravity knife law. Most recently, he worked as a policy attorney in Legal Aid's Criminal Defense Practice, coordinating their legislative reform agenda before the [New York City Council](#) and New York State Legislature.
