**David L. Gregory**, *Professor of Law*



Professor Gregory's article [The Long View of the NLRA at 70... Or, The More Things Change](#), was published at 56 *Labor Law Journal* 172. In addition Professor Gregory's 2005 summer research project, [Why Not a General Strike?](#), has been accepted for publication in the [Notre Dame Journal of Law, Ethics, and Public Policy](#). Professor Gregory also participated with several other labor law professors in an October 14 amicus brief to the Second Circuit in *Health Care Association of New York State v. Pataki*, which argued that the New York law constraining private employers from using state funds to deter union organizing is not preempted by federal law.

**Lawrence Joseph, Rev. Joseph T. Tinnelly, C.M., Professor of Law**



Professor Joseph's two recently published books of poetry – [\*Into It\*](#) and [\*Codes, Precepts, Biases, and Taboos: Poems 1973-1993\*](#) – continued to receive favorable reviews. *Codes* was named an "Editor's Choice" in the October 2 Sunday *New York Times Book Review*. In an essay entitled [\*The Poetry of Judicial Opinions\*](#) in the September/October issue of [\*Legal Affairs\*](#), University of Pennsylvania law professor David Skeel called Professor Joseph "the most important lawyer-poet of our era" and noted that he is "admired for his use of the public language of law, finance, politics, and international conflict, in poems that investigate the corridors of power, often from the inside." In an October 21 review in the *New York Law Journal*, Daniel Kornstein called Professor Joseph "one of those rare poets who have succeeded in combining law with literature." Professor Joseph's work was also featured in [\*Well-Versed in Detroit Images\*](#), by Bill McGraw, in the *Detroit Free Press* on October 20 and in an essay review of both new books in the September/October issue of *The New Leader*.

On October 19, Professor Joseph [read](#) from both new books at the University of Michigan in Ann Arbor as part of Michigan's [Zell Visiting Writers Series](#). On October 20, he read at [Marygrove College](#). On October 21, he taught a class on poetry to high school students from Detroit Public Schools at Marygrove College.
