I. Opening Prayer

The meeting began at 3:25 p.m. Dr. Moller welcomed all in attendance. Dr. Charles Traina offered the opening prayer.

II. Approval of the Minutes of April 19, 2021

The minutes from the meeting held on Monday, April 19th were approved as corrected.

III. Committee Election Reports

V. New Business / Updates

Enrollment

Dr. Moller gave an update on Enrollment. He mentioned a strategy change which has increased deposits, although overall applications are down. He stated that the discount rate will remain as it is very difficult to roll back once it is increased. Presidential Scholarships have been reduced and that money will be distributed among other students to increase yield. A Faculty Ambassador Program has been instituted where faculty members communicate with admitted students via handwritten notes. We must showcase the value of a St. John's education to prospective students through enhanced marketing programs and a personalized approach.

Signature Experience

Dr. Moller gave an overview of the plan to create a Signature Experience for each student where we will showcase the value proposition of a St. John's education. It is expected that this will become part of the developing Strategic Plan. The St. John's Signature Experience will be a platform for all student to visualize their educational journey at St. John's, detailing the relevance and interconnectivity of courses, as well as extra- and co-curricular opportunities.

UCCC

Dr. Phyllis Conn gave an update on the work of the UCCC. An Ad Hoc committee was formed about two years ago and this committee, in collaboration with the UCCC, has spent significant time on creating a collaborative core vison and a draft University Core proposal. Both the vision statement and the University Core are meant to be living documents that will be continually assessed and adapted if needed as we move forward. The new draft University Core will be presented to the Curriculum Committees of the various Faculty Councils and the Educational Programs and Development Committee of the Senate. Ultimately, the final version of the core curriculum will be presented by the UCCC to the BOT for final approval.
