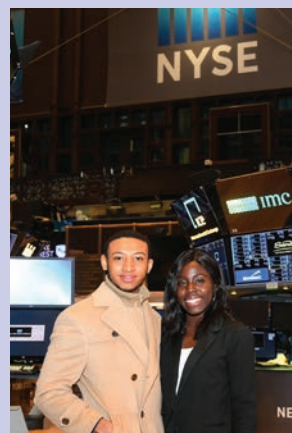
UNIVERSITY CAREER SERVICES

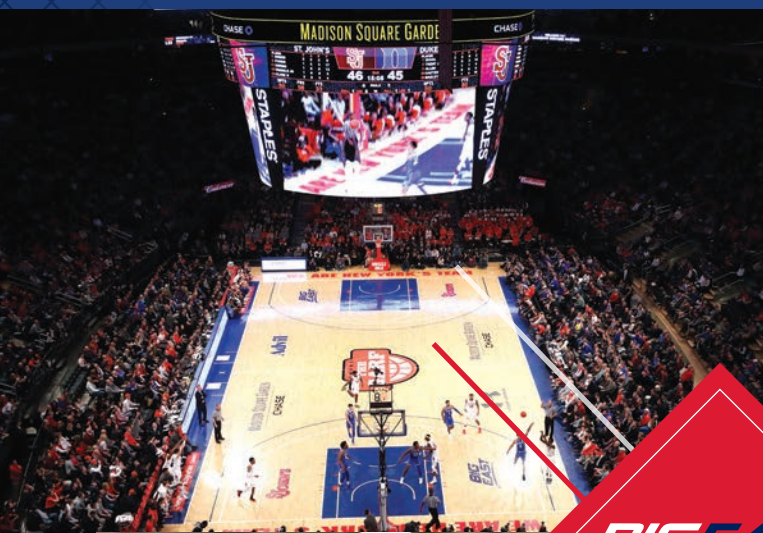

Your New Opportunity

University Scholarships and Awards

For more than 150 years, St. John's University has built a legacy of making a world-class, private education accessible to any student who seeks it. Below are the requirements needed to maintain an academic scholarship at St. John's.

- You must be enrolled at St. John's University for a minimum of 12 credits per semester (fall and spring).
- A minimum cumulative grade point average must be maintained at the end of each academic year in accordance with the scholarship awarded.

Scholastic Excellence Scholarship	3.0
St. Vincent de Paul Scholarship	3.0
Academic Achievement Scholarship	3.0
Student Success Award	2.0

- Scholarships for first-time, first-year students are for up to four years of full-time, continuous, undergraduate study at St. John's University.
- Scholarships are only available for fall and spring terms (scholarships are not available for summer, winter, mini, or post sessions).
- Scholarships and University awards offered to students in dual degree and/or joint degree programs are only renewable for periods of enrollment at St. John's and only for the undergraduate portion of a program.
- Scholarships and University awards offered to students entering the six-year Doctor of Pharmacy (Pharm.D.) program are only renewable for periods of enrollment at St. John's and only for the undergraduate portion (first four years) of the program.
- The combination of all scholarships and grants cannot exceed tuition. The University reserves the right to adjust institutionally funded scholarships and grants.

Tuition and Billing

St. John's University sends electronic bills (eBills) beginning in June for the fall semester and November for the spring semester. All students or authorized users (e.g., parents or someone approved by the student to pay the student's bill) receive an email notifying them their bill is now available, along with instructions on how to view and make payment arrangements.*

Social Security Number

US citizens and/or eligible noncitizens who have completed FAFSA®, or are considering doing so, must have a valid Social Security number on file with the University. If your number was not included on the admission application, please log in to the secure University Information System (UIS) at www.stjohns.edu and follow the steps below to add your Social Security number to your University student record:

- Visit www.stjohns.edu.
- At the bottom of the page in the footer, click on MySJU.

All St. John's University students who register for courses and utilize University services are required to electronically sign (e-sign) a Student Financial Responsibility Agreement (SFRA). This agreement helps make sure students understand their financial obligations to the University. The agreement must be completed at least once every academic year the student is enrolled.

**Students who enroll in The Peter J. Tobin College of Business or the Doctor of Pharmacy (Pharm.D.) program in the College of Pharmacy and Health Sciences should note the tuition differential applied beginning in their third year.*

- Click on UIS. You will be asked to log in with your User ID and PIN. If you have not received your St. John's University X-number and PIN, contact the Office of Admission at 718-990-2000.
- Select "Personal Information."
- Select "Update Biographical Data."
- Enter the correct Social Security number.
- Click "Submit" to save.

The University collects Social Security numbers for use in administering federal and state grant/loan programs, student employment and for use in complying with IRS reporting requirements pertaining to the American Opportunity Tax Credit and Lifetime Learning Credit. Information concerning educational tax credits can be found on the IRS website, www.irs.gov. The University cannot determine whether you are eligible to claim this tax credit. Therefore, please consult your tax advisor to determine the amount of tax credit, if any, that you may be eligible to claim.

Submit Your Enrollment and Housing Deposit

To secure your enrollment, submit your nonrefundable deposit:

- Undergraduate enrollment deposit: \$300
- Undergraduate housing deposit: \$400.

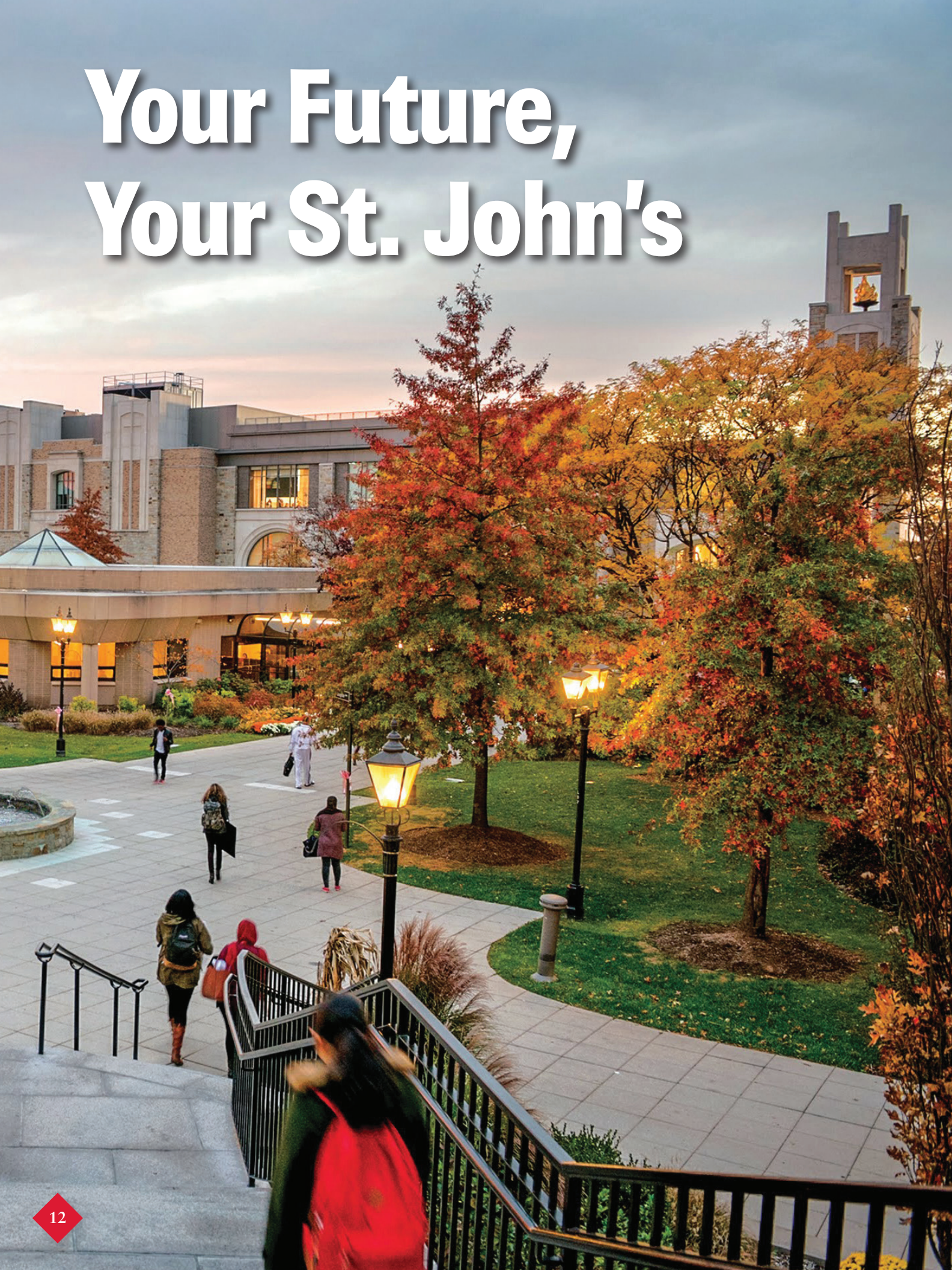
Students are strongly encouraged to review the *Undergraduate Bulletin* found online at www.stjohns.edu/Bulletin. The bulletin serves as the student guide to academic requirements, tuition and fees, course registration, and financial aid policies and procedures.

**If accepted for Early Decision admission, the enrollment and housing deposit deadline is January 15. For additional information and details regarding how to submit your enrollment and/or housing deposit, visit www.stjohns.edu/Tuition.*

***All students are required to provide proof of high school graduation or equivalent. Proof of high school graduation includes a final, official high school transcript with date of graduation; a state-issued diploma; or the GED (General Education Diploma) or other state-approved equivalency assessment through TASC (Test Assessing Secondary Completion).*

In-state homeschool students must submit an official document from the state Department of Education or the superintendent of their school district that attests that the homeschool education is equivalent to a high school diploma. Out-of-state homeschool students must submit a copy of their state-issued diploma or obtain a High School Equivalency diploma.

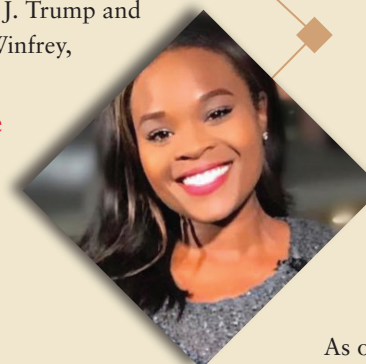
