I. Title of Workshop: Using the MMPI-2 and MMPI-3: Going Beyond the Diagnosis Description

Learning Objectives:

This workshop focuses on the clinical use of the MMPI-2 and MMPI-3, exploring the foundations of these major personality tests and how they provide a more comprehensive assessment of personality functioning that goes well beyond a psychiatric diagnosis. \

- 3. Review the strengths and limitations of these major objective tests of personality.
