Certificate of Eligibility

- Obtained via Department of Veteran Affairs
 - E-Benefits
 - www.ebenefits.va.gov
 - -(888)442-4551
- Must be dated within current academic year
- If transferring from another school, must submit up-to-date COE, indicating:
 - Payments made to other institution within current academic year
 - Remaining entitlement (months), percentage



Yellow Ribbon Program

- Must be covered at 100%
- Active Duty service members and spouses are not eligible for Yellow Ribbon
 - Need DD214 if COE indicates that student is Active Duty
 - SJU will only match what VA actually pays in Yellow Ribbon funding
 - Ex: YR originally posted as \$5,000 for SJU & VA, but if VA only sends \$2,500 Yellow Ribbon payment, SJU will adjust SJU YR to match VA payment



Remaining Entitlement

- Students are responsible for keeping track of their remaining entitlement.
- St. John's University estimates:
 - 4 Months for Fall
 - 4 Months for Spring
- Winter Sessions and Summer sessions are also deducted from remaining eligibility
 - Winter: Approximately 2 weeks
 - Summer Session 1 & 2: Approximately 1 month each
 - Summer Session Pre & Post: Approximately 2 weeks
- Ex: If COE indicates 36 months of total eligibility, deduct 4 months starting with the first semester enrolled. Student will have approximately 28 months remaining.



Summer Enrollment

- Each Summer Session is treated as a separate enrollment period by the Department of Veteran Affairs
- Must enroll in 12 credits throughout the course of the Summer to receive full-time BAH
- BAH is paid based on number of days student is in classes during enrollment period Student will not receive same BAH in FA/ SPR
- To qualify for the full time BAH, you MUST enroll in One resident class per enrollment period
 - − Pre Summer Session: 5/16/16 − 5/26/16
 - Summer 1: 6/1/16 7/6/16
 - Summer 2: 7/11/16 8/11/16
 - Post-Session: 8/16/16 8/25/16



What expenses are NOT covered under Post 9/11 GI Bill?

- Room and Board
- Macbook Fee or Accidental Damage Protection Laptop
- Parking fees
- Parking Permit
 - Payment must be made via UIS and within 72 hours student veterans will be 100% reimbursed
- Security Damage Deposit Residence Halls
- Study Abroad program fee, airfare, etc.
- Other miscellaneous expenses
 - If you have questions regarding other items not covered by the Post 9/11 GI Bill, please contact the VA or a VA Certifying Official



Study Abroad

- Under Ch.33, VA will pay toward:
 - Home school's tuition and fees
 - Books and supplies
 - Monthly housing allowance based on the home school's address and credit load
 - In order for VA to pay any additional fees specific to the Study Abroad option must be required for graduation
- VA <u>will not</u> cover:
 - Costs related to travel (airfare, lodging & meals)
 - Third party charges



Health Insurance

- If you're not covered under any health insurance plan, the Department of Veteran Affairs will cover the SJU Health Insurance premium
 - Student must written notification to School Certifying Official that they're not otherwise covered and would like SJU to charge their account
 - Student must contact Kyle Dehaney (<u>dehaneyk@stjohns.edu</u>) so that
 Health Insurance charge can be posted to student account
- If you're covered under a health insurance plan and are charged health insurance, please go to www.universityhealthplans.com and the charge



How To Apply For Financial Aid

- ➤ Complete the Free Application for Federal Student Aid (FAFSA).
- ➤ It is the only application you will need to be considered for all sources of financial aid at St. John's University.
- Go to www.fafsa.ed.gov to file
 - > Create FSA ID
 - ➤ St. John's University School Code is 002823
 - ➤ Complete IRS Data Retrieval if possible





Federal Grant Aid

- Eligibility determined by the FAFSA
- Programs are:
 - Federal Pell Grant:
 - **❖**2016-2017 maximum award is \$5,815 for the year
 - ❖ Based on student's EFC
 - Supplemental Educational Opportunity Grant (SEOG)
 - ❖Must be Pell eligible
 - ❖ Availability based on Federal funding levels
 - ❖ Average award offer at St. John's University is \$1,500 for the year



New York State Grant Programs

- ➤ Not eligible if covered 100% under Post 9/11 GI Bill
- > Student must be a resident, attend a college in NYS and be enrolled at least half-time
- ➤ Eligibility is based on NYS net taxable income
- > Current Maximum award is \$5,165 for the academic year

Early Refunds

- Student Veterans covered 100% by Post 9/11 GI Bill or Vocational Rehabilitation & Employment are eligible for early refund of Pell Grant or Federal Direct Student Loans
- Issued within first two weeks of school
- If selected, verification of financial aid package must be complete prior to receiving refund
- Ineligible if student owes past due balance or has holds on their account
- Please send email to Karen Morizio (moriziok@stjohns.edu) or Marion Concilio (concilim@stjohns.edu) to request for an early refund
- Early refund agreement will be sent to student and student must reply "I agree to the terms listed in this email"



Confirm Enrollment

- Must be done prior to start of each semester
- Must be completed even if there is a zero balance or a credit balance
- Financial obligation must be satisfied in order to confirm enrollment
- If this is not completed, your classes will be dropped
- We will be unable to certify your enrollment with the VA until you have confirmed your enrollment.
- Instructions:
 - Log into UIS
 - Click Student
 - Click Registration
 - Click View/Confirm Term Bill
 - Select the current term (ex: Fall 2016)
 - Click Confirm Enrollment Button on top of screen



Certification Process

- Occurs twice per semester
 - Initial Certification
 - \$0 Tuition & Fees reported Only credits reported at this time [Occurs mid August for Fall semester]
 - After the "drop period" of each semester tuition, fees and credits will be certified [Occurs mid October for Fall semester]
- Same process occurs for Spring, Summer and Winter semesters.
- Students will only be certified with the VA once they have confirmed enrollment at SJU
- Automated email will be issued once you're certified –
 Please review



Stipends

- Books and Supplies Stipend
 - Issued by VA once per academic year
 - Amount of stipend depends on enrollment status
 - Ex: Undergraduate
 - Full time (12- 18 crs = 100%), $\frac{3}{4}$ Time (7-11 crs)
 - Ex: Graduate
 - Full time (9crs), ½ time (6 crs)
- Monthly Housing Stipend
 - Issued by the VA approximately 30 days after the start of term
 - Contact VA to establish direct deposit
 - At least one class must be on campus in classroom in order to receive full stipend
- Stipends will be prorated by Department of Veteran Affairs if the student drops to part time enrollment
 - Full time (12-18 crs = 100%),
 - $\frac{3}{4}$ Time -- 7crs = 60%, 8crs = 70%, 9 & 10 crs = 80%, 11 crs = 90%



Fry Scholarship

- Provides benefit eligibility for children of active duty members of the Armed Forces who died in the line of duty after September 10th, 2001.
 - Eligibility Requirements:
 - May be married or over 23 and still eligible
 - Entitled to 36 mo. Of benefits at 100% level
 - Have 15 years to use the benefit beginning on their 18th birthday
 - May use benefit until 33rd birthday
 - Are not eligible for Yellow Ribbon



Current Tuition and Fee Caps 2016 – 2017

- 100% \$21,970.46 Not eligible for NYS TAP
- 90% \$19,773.41
- 80% \$17,576.37
- 70% \$15,379.32
- 60% \$13,182.28
- 50% \$10,985.23
- 40% \$8,788.18
 - Tuition and Fee cap is subject to change per academic year
 - If your percentage increases or decreases, you must advise the St. John's University School Certifying Officials and provide an updated copy of the revised Certificate of Eligibility



Tuition and Fee Caps

- Percentage Covered
 - When covered 40% 90% the VA will only pay until the cap pertaining to a student's percentage level has been exhausted for the academic year
- Ex: Student is covered at 90%:
 - Cap for Academic Year = \$ 19,773.41
 - Fall 2016 Tuition & Fees charged to student = \$19,730
 - \$19,730 x .90% = \$17,757 Post 9/11 GI Bill Award Fall 2016
 - Maximum 'cap remaining' for Spring 2017 = \$2,016.41



Withdrawn Courses/ Unofficial Withdrawals

- As per the Department of Veteran Affairs:
 - A debt is established on the student for tuition/fees/yellow ribbon when:
 - If the student attended at least one day of any of the classes certified and a payment has been issued by the VA, any debt created by the reduction/ withdrawal will be charged to the student
 - Unofficial Withdrawal and Withdrawn Courses must be reported to the Department of Veteran Affairs by St. John's University
 - The VA will determine if any resulting debts will be assessed to the student

Chapters 35,30,1606

• The University certifies enrollment for student's under these chapters for tuition, fees and credits

• The VA submits payment directly to the student, not the University

• If your eligibility changes from one chapter to another, you must advise the St. John's University School Certifying Officials as soon as possible



Vocational Rehabilitation – Ch. 31

- Tuition, Fees and Credits certified for the Vocational Rehabilitation counselor each semester
 - The University bills the Department of Veteran Affairs after the withdrawal period
 - The Department of Veteran Affairs will send payment for tuition and fees directly to University.
- Student obtains book stipend certification form from Voc. Rehab. counselor to purchase books at SJU book store
