If you are seeking testing accommodations for the Uniform Bar Exam “UBE” (for any state), the New York Law Exam “NYLE”, and/or the Multistate Professional Responsibility Examination “MPRE,” you should contact the [Office of Disability Services \(ODS\)](#) at [disabilityservices@stjohns.edu](mailto:disabilityservices@stjohns.edu) to request a letter be mailed to you verifying you as a registered student and your accommodations. The letter will be mailed directly to you, which you can then provide to the testing board(s). Please allow 1-2 weeks to process your request.

**\*IMPORTANT:** Candidates must apply for accommodations and receive their determination prior to registering and scheduling an MPRE test appointment. Accommodations cannot be added to an existing test appointment. Applications should be submitted well in advance of the desired MPRE test administration, and no later than the Recommended Submission Date for that administration.
