Description of Courses Taught

EDU 6127 Introduction to Counseling

(Fall 2025)

This course is designed for the beginner level of school and mental health counseling. It will provide students with knowledge, perspectives, and an introduction to the skills necessary for effective practice as a culturally competent counselor. Students will be introduced to the essential concept of successful counseling by learning about the interaction of ethical and legal standards and practices, technology, current research, and best practices.

EDU 6206 Psychosocial Development: Across the Lifespan

(Summer 2025)

This course provides an overview of human growth and development, across the lifespan. This course focuses on the psychosocial factors involved in understanding individuals across the lifespan, in various cultures, including: current understanding about neurobiological behaviors, models of psychopathology and resilience as well as their relationship with positive development and mental health.

EDU 6270 Case Conceptualization, Treatment Planning, and Pharmacology

(Spring 2023, Fall 2023, Spring 2025)

This seminar course in mental health counseling will develop advanced interviewing skills and techniques necessary for differential diagnosis, case conceptualization, and treatment planning using the DSM 5, as well as for maintaining and terminating the psychotherapeutic relationship. The appropriateness of consultation and collaboration with other mental health providers will be discussed. In addition, the basic classifications, indications, and contraindications of commonly prescribed psychopharmacological medications will be studied, along with a discussion of the need for appropriate referrals for medication evaluations.

EDU 6301 Career Development

(Spring 2025)

This course will enable students to acquire the knowledge and skills necessary to understand and intervene in other individual's career development as well as understand the variables influencing their own career path. Interrelationship among lifestyle, work place, and career planning are explored. Career development theories, occupational, educational and personal/ social information sources and delivery systems, and organization of career development programs are studied.

EDU 6310 Practicum in Mental Health Counseling

(Fall 2023)

This course consists of placement in an approved clinical setting (hospital, outpatient clinic, etc.) for a minimum of 100 hours during which the student will engage in a minimum of 40 hours of direct service with clients and the remaining hours performing indirect services under the supervision of an approved site supervisor. The practicum experience provides students with the opportunity to integrate theoretical knowledge with practical experience and to apply particular treatment approaches specific to client populations. In addition to the on-site supervision, students will participate in a weekly on-campus seminar in which group supervision will be provided. A comprehensive case study is required as part of this course.

EDU 6311 Internship in Mental Health Counseling I

(Summer 2023)

This course consists of placement in an approved clinical setting (hospital, outpatient clinic, etc.) for a minimum of 300 hours during which the student will engage in a minimum of 120 hours of direct service with clients and the remaining hours performing indirect services under the supervision of an approved site supervisor. The internship experience is the second field experience for students and provides them with additional opportunities to enhance their clinical interviewing and assessment skills, individual and group counseling skills, and consultation skills under the supervision of an approved supervisor. In addition to the on-site supervision, students will participate in a weekly on-campus seminar in which group supervision will be provided. A comprehensive case study is required as part of this course.

EDU 6312 Internship in Mental Health Counseling II

(Fall, 2022, Fall 2023, Summer 2024)

This course consists of placement in an approved clinical setting (hospital, outpatient clinic, etc.) for a minimum of 300 hours during which the student will engage in a minimum of 120 hours of direct service with clients and the remaining hours performing indirect services under the supervision of an approved site supervisor. The internship experience is the third field experience for students and provides them with additional opportunities to enhance their clinical interviewing and assessment skills, individual and group counseling skills, and consultation skills under the supervision of an approved supervisor. In addition to the on-site supervision, students will participate in a weekly on-campus seminar in which group supervision will be provided. During the on-campus seminar topics on counselor wellness will also be explored. A comprehensive case study is required as part of this course.

SKCS 102 Psychological, Social and Academic Development

(Fall 2017, Fall 2018, Fall 2019, Fall 2020)

A forum for students to discuss a variety of topics related to their college roles and responsibilities, including personal development, interpersonal relationships, academic demands, career choices, and college resources.

SKCS 103 Developing Self-Awareness for Academic Success

(Spring 2017, Fall 2017, Spring 2018, Spring 2019, Spring 2020)

This course incorporates an interdisciplinary perspective which will provide students the opportunity to develop deeper insight into personal and social issues that impact their academic success. The topics covered include personal development, interpersonal relationships, and career choices as they pertain to students' roles and responsibilities.
