COVID-19 Emergency Assistance Funds

Federal CARES Emergency Grant Funding

The CARES Grant is a one-time grant designed to be used to assist with expenses related to the disruption of campus operations due to coronavirus pandemic such as food, housing, course materials, technology, health care, and child care.

To be considered for this grant students must have been directly impacted by COVID-19 and have a valid **2019-20 FAFSA** on file, meet all basic federal aid eligibility requirements and be enrolled in ground-based education (on campus courses).

Grants are not considered to be financial aid and funds will be sent directly to grant recipients.

St. John's University COVID-19 Emergency Grant

St. John's University Emergency Grant Fund is designed to provide students the opportunity to apply for a one-time only grant for the 2020-21 Academic year.

To be considered for this grant students must have been directly impacted by COVID-19 and have a valid 2020-21 FAFSA on file. Recipients must meet all basic federal aid eligibility requirements, demonstrate financial need and be in good academic standing. Recipients must be matriculated undergraduate degree seeking students enrolled at least half-time for the summer 2020 semester and/or enrolled full-time for the Fall/Spring 2020-21 Academic year.

Grants will be treated as 2020-21 financial aid and posted to students account and applied toward University Summer 2020 or Fall/Spring 2020-21 charges. Applications will be reviewed and awards offered on an ongoing basis until funding is exhausted, so students are encouraged to apply in a timely manner.
