I, the above named student, (hereinafter the "Student" or "I") hereby enroll in the Staten Island Three Year Bachelor's Degree Program (the "Program") at St. John's University, New York (the "University" or "St. John's").

By signing this agreement, I agree to abide by and be subject to the terms and conditions set forth below:

The following items and conditions apply:

By enrolling in the Program, undergraduate tuition will be fixed at forty thousand four hundred dollars (\$40,400) for each of the next three consecutive academic years. However, if I am a student enrolled in St. John's The Peter J. Tobin College of Business, I will be required to pay, upon completion of 56 credits an additional tuition charge, which charge shall vary from year to year. By way of example, the additional charge for the Tobin College of Business for the academic year 2012-2013 is \$1,480.

Notwithstanding the foregoing, the Program only covers basic tuition charges. University fees and room and board charges are not included in the cost of the Program and are subject to change.

In addition to the terms and conditions contained herein, the Student hereby agrees to adhere to the terms and conditions (as modified from time to time) outlined on the Three-Year Bachelor's Degree Program Web site at: www.stjohns.edu/campuses/si/undergraduate/three.

I hereby agree and acknowledge that my eligibility for the Program, including the fixed tuition rate stated above, is contingent upon my remaining in good academic standing at the University. In connection therewith I must maintain a minimum cumulative grade point average of 2.50 or greater following the first two semesters in which I have enrolled as a full-time student. If I fail to remain in good academic standing and maintain the required GPA I will forfeit my eligibility in the Program and my ability to obtain fixed tuition and shall thereafter be charged the then prevailing tuition rate.

I further agree to adhere to the additional academic requirements, including but not limited to grade point average, required by the major I have selected.

I shall comply with the rules, regulations, bylaws, guidelines and policies of St. John's, including but not limited to the student conduct guidelines, graduation and matriculation requirements and the Student Handbook. This Program does not in any way impair or inhibit St. John's rights to enforce said rules, regulation, statutes, bylaws and guidelines.

Students who drop below 18 credits during any fall or spring semester, or below 9 credits during any summer session (or 12 credits for students enrolled in a School of Education summer session), are required to consult with their academic advisor regarding their ability to complete the Program within the stipulated three year period. If a Student is unable to complete his/her program within the time period allocated for the Program, the Student may, in St. John's sole discretion,

be declared ineligible for the Program, and as a result, the Student will forfeit his/her eligibility for the fixed-tuition rate and will thereafter be charged the then prevailing regular rate of tuition.

Depending upon course availability, Students may be advised and/or required to complete courses offered at another campus of the University or via distance learning in order to allow those Students to complete their degree within three years.

Students' participation in the Program is contingent upon their participation in a Global Studies study abroad experience during their first summer session. Failure to participate in a summer session abroad experience shall result in the Student forfeiting his/her eligibility to participate in the Program and obtain the corresponding fixed tuition rate. If a Student forfeits his/her eligibility for the fixed tuition rate, the Student shall thereafter be charged the then prevailing regular rate of tuition. Notwithstanding the foregoing, the student may defer his/her participation in a summer study abroad session for up to one year if and only if: (i) the Student notifies the Associate Dean of his/her respective College/School in writing of the existence of an extenuating circumstance which will prevent Student from participating in the study abroad session and (ii) the Student provides the Associate Dean with written documentation substantiating the extenuating circumstance. Such extenuating circumstances may include, without limitation, a severe medical issue and/or financial hardship. In connection with the study abroad experience, Students will not incur a tuition charge or Program related fee. Notwithstanding the foregoing, Students shall be responsible, at their sole cost and expense, for the cost of their flight, meals and other out of pocket expenses. Furthermore, Students are required to adhere to all rules and regulations established by the Office of Global Studies from time to time and shall work closely with the Office of Global Studies in all aspects of the study abroad experience.

Pending dormitory and/or off-campus apartment availability, as well as the location and/or availability of students' required courses, participants in the Program may be required to reside at a campus of St. John's University other than the Staten Island campus during summer sessions.

Upon completion of this form, the submission of the non-refundable \$300 deposit, and the receipt of the confirmation form, the terms and conditions of this letter shall apply and Student shall be eligible for eligibility in the Program and the corresponding fixed tuition rate.

ADDITIONAL TERMS AND CONDITIONS OF THIS AGREEMENT

These terms and conditions as well as the conditions stated above shall be read together and shall constitute one agreement (the "Agreement").

In order to provide a means of stabilizing tuition expenses for the student and/or parent or guardian of the student, St. John's University is offering a Three-Year Bachelor's Degree Program on its Staten Island Campus (hereinafter the "Program"), which has a corresponding fixed tuition rate for the three consecutive years of the students' undergraduate studies.

The Program shall only be made available to incoming, full time freshmen for the 2012-2013 academic year and shall not apply to any currently enrolled, transfer or re-admitted student. This Agreement is made by and among St. John's University, New York ("University"), an educational institution organized and existing under the laws of the state of New York, and the undersigned University student, parent or guardian (hereinafter the "Student").

Notwithstanding the foregoing, the Program only covers basic tuition charges. University fees and room and board charges are not included in the Program and are subject to change.

As a condition to the Students' eligibility in the Program and the ability to obtain the fixed tuition rate, Students are required to attend summer classes as part of the Three Year Degree Program. By failing to attend Summer sessions, Students will forfeit their eligibility in the Program and their right to obtain fixed rate tuition and, as a consequence, will be charged the then prevailing regular rate of tuition. In connection with a Students' attendance for summer sessions, the Student will not be charged tuition provided that the courses that the Student enrolls or intends to enroll in can be used to complete the Program.

If a Student withdraws at any time, he/she is required to adhere to the refund schedule set by the Office of Student Financial Services.

This Agreement is only valid for three consecutive academic years. Students who fail to graduate within the three year allocated period under the Program shall pay the then prevailing tuition rate.

If you are a Student enrolled in St. John's The Peter J. Tobin College of Business, you will be required to pay an additional tuition charge upon completion of 56 credits, which charge shall vary from year to year. By way of example, the additional charge for the Tobin College of Business for the academic year 2012-2013 is \$1,480.

If a Student fails to attend one or more consecutive academic semesters, this contract is null and void and the Student will forfeit his/her eligibility to participate in the Program. In such a case, the corresponding fixed tuition rate shall no longer apply and the Student shall be charged the then prevailing regular tuition rate.

Students who drop from full-time status to part-time status will forfeit his/her eligibility to participate in the Program and receive the corresponding fixed rate tuition. In such a case, the Student will be charged the then prevailing regular tuition rate.

The Plan cannot be assigned to any other person who is not a party to this Agreement and the benefits hereunder cannot be applied to another student.

The Plan only applies to incoming, full-time freshmen who intend to enroll in the three year, undergraduate, bachelor degree program and shall not apply to any other students, including without limitation students in the combined B.S./J.D. or B.A./J.D. B.S./M.S., B.A./M.S., B.S./M.A., B.A./M.A., B.S./M.B.A. degree programs at St. John's University.
